	Jan FRASAC – the esplanade in Kirkcaldy is accessible for partners to arrange face 2 face meetings including the police to take statements. A dip in referrals was noted initially however now creeping up. Social isolation has been good for some but some are struggling. Active service users are receiving support and from 1 July services will try to return to normal. Staff have been making food deliveries and the needs of service users are being met. Jan thanked Fife Council and partners. Tricia Safer Communities – asked if the paper is available to share. She stated Councillor Kennedy had asked for safer community updates and specially enquired about FVAWP. Kate – Fife Women's Aid is increasing contacts. There is online groupwork and essential face to face work has taken place. Gradual process however partnership working has been fantastic and Kate gave her thanks. Paul, Housing – Working hard to address issues and housing are still being allocated to those who suffer domestic abuse. All services running and good contacts taking place. Any issues are being picked up quickly Looking to increase services and parentship working has been excellent. Deborah, Education – Schools are engaging all families and supporting vulnerable families working closely with social work. CP children are attending the child activity centres and there is a clear expectation on staff. 	Currently working on a recovery plan and there are concerns about returning to school. Children's Hearings and IRDs are continuing and looking at children at risk at home. Penny, St Andrews University – a number of undergraduates were not able to return home and around 400/500 remain. Student support continues to offer counselling online and some students prefer this and will continue in this way. Concerns regarding privacy and updates are shared on the website. Consent and bystander intervention training is not happening at the moment for 2000 students and Freshe'rs week will also not be happening. Joy, KASP – All clients have been offered phone contacts or zoom meetings. There are no staff working from the offices and paid workers are picking up the work of volunteers. An influx of referrals has been received and contact is made by phone, teams, zoom, emails and Joy is hopeful that the volunteers will be back in the next 2 weeks, and support offered to clients in the best way possible. Elizabeth ADP are maintaining all scripts. All other services are receiving online or phone support which has had a better response to this than before, pre and post covid. Barriers have dropped. New referrals available to services and the opportunity for disclosure is missed as no face to face contact is made with women or children. All families have been given mobiles.
